Department of International Police of the Association of International Agency of Public Security

Full name in English language – “Department of International Police of the International Agency of Public Security”

Short name in English language – “Department of International Police”, “DIP”.

1. General regulations

- 1.1. Department of the International Police (Department) is the structural unit of the Association of “International Agency of Public Security”.
- 1.2. Guidance of the Department is performed by the recruited international experts of the International Police Corporation of Public Security (Kyiv, Ukraine), hired by Association according to the Special Service Agreement.
- 1.3. Personnel an arrangement of the Department is formed according to the internal Regulation of the Department and based on current and strategic goals of the Association, and should be submitted by the Director of Committee and General Secretary of the Association.

2. Objective and Main Tasks of the Department

- 2.1. Main objective of the Department is to provide assistance to the self-governments, executive bodies, law-enforcement and special agencies of states to counteract terrorism, international organized crime, corruption and illegal migration, as well as providing assistance in maintaining of public order and road safety, guarding of state borders.
- 2.2. For the execution and accomplishment of the aforesaid objective the Department puts forward the following tasks:

- 2.2.1. Establishment, strengthening and development of close cooperation and interaction with law-enforcement and special (intelligence/security) agencies of states, with other executive bodies and local self-administrations on the sphere of enhancing of public order and road safety, counteracting terrorism, international organized crime, corruption and illegal migration;
- 2.2.2. Contribute in creation in public mind of friendly and respectful attitude to the officers of law enforcement bodies and special agencies of states, to be ready to assist them in protection of democratic interests of the societies and states;
- 2.2.3. Assist and holding of scientific and practical studies and analytical researches on the related matters;
- 2.2.4. Studying, analysing and developing of the informational-analytical products in the sphere of public safety and democracy;
- 2.2.5. Participate internationally in organization and holding of educative activities (lections, seminars, consultations, other arrangements) which should be directed to analysis and clarification of existing problems of safety securing, public order maintenance, protection of human rights, finding solutions and improvements in the sphere of human rights and freedoms protections, level of information availability to the public on programs, tendencies, problems and prospects of public development, wider circle of related matters both theoretical and practical;
- 2.2.6. Maintain constant relations, experience exchange and various forms of cooperation with the other international and local associations of citizens, including political parties, international and foreign public organizations in the sphere of public development, solution of problem of democratization and protection of rights and freedoms of the citizens;
- 2.2.7. Thorough assistance to the protection of constitutional, namely political, social, scientific rights and interests of members of the Association through the representation of these rights and interests in the bodies of the state power, local administration, public organizations of states, at the international meetings, conferences, rendering of information and methodological assistance to the members of Association;
- 2.2.8 Creation of the network of international and local departmental units on the basis of their structural subordination and acceptance of the objective and tasks of the Association;
- 2.2.9 Organization and publishing of international and local periodicals on urgent topics of construction of democracy and the other problems in the sphere of public safety and order;
- 2.2.10. Organization of security for the Association and its members, as well as performing other activities, which are focused in the framework of main goals and tasks of the Association, and do not have a goal to obtain profit.

2.3. For the achievement of objective and tasks of the Association, the management of the Department conducts the following:

Performs any activity which is not prohibited by the law and necessary for the execution of the statutory tasks of the Association;

Create functional structure of the Department and make organizational and structural changes;

Establish and enhance cooperation with law-enforcement and special-service agencies of states, organize official correspondence and informational exchange with the prescribed agencies;

Create Awarding Committee for recording and honouring of the most important achievements in the sphere of human rights protection, insuring of law and order by citizens and officers of law enforcing bodies;

In the framework of the Department independently plan, organize and execute all the kinds of legal activity;

Award associational members by providing special public ranks for them (from lieutenant to general-colonel) allowing them to wear uniform of the Association, and issuing the service ID-cards allowing them to perform tasks of the Association. Special ranks, uniforms, and service ID-cards are regulated by the relevant Regulation of the Department;

Create and perform administration of databases of international experts (closed and publicly opened) to carry out statute goals and tasks of the Association, other governmental and non-governmental organization, with the process of issuing of the International Expert Certificate for the experts of Association, approved by the relevant Regulation.

Get assistance in a form of money or property that are provided on a grant basis or as irrevocable financial assistance or voluntary donations, grants, including to get humanitarian aids, solve the purpose of use of voluntary donations, grants, membership and the other fees received by the Association;

Organize collection of donations, grants, contributions, humanitarian aid from physical and legal persons, international and foreign organizations;

Represent and protect its legal interests and legal interests of its members at the state and public bodies, courts, law enforcing bodies, at enterprises, institutions, and other organization;

Form respective funds for covering of eventual loss to the members of the Association, which they may sustain at the execution of the statutory tasks of the Association;

Perform measures, related to the realization of the main tasks of the Association, to engage specialists, interested persons and organizations;

Found international and local representations of the Department, according to the legislation in force;

Organize and participate in holding of seminars, lectures, conferences, scientific practical arrangements;

Promote its name and symbolic, registered in order stipulated by the law;

Exchange information as well as special and practical experience with the foreign respective organizations;

Propagate information about its objective, tasks and activities;

Provide organizational and financial support to the other public organizations, which principles and tasks of activity concur with objective and tasks of the Association and to render assistance in their establishment;

Get from the state and government bodies, local authorities and institutions any information necessary for realization of the Association's purposes and tasks;

Provide the members of the Association with literature, appliances, audio-, video-products and the other information materials and office accessories, to encourage them with material and moral stimulation and organise their rest and leisure;

Use the other rights stipulated by the law.
